Sub: **Provisional Regional Energy Accounting (REA) of Eastern Region for the month of March 2010.**

Sir,

Please find enclosed a copy of the ABT based Provisional Regional Energy Account for the month of March, 2010 for further necessary action by the constituents.

The following considerations were made in the preparation of REA for this month :

- a) The REA for the month has been prepared provisionally considering AFC existing till 31.03.2009 for all the ISGS & ISTS of the region (until finalisation by CERC) and based on norms as per provisions made in the CERC Tariff Regulation 2009. The annual fixed charge for Rangit HPS of NHPC vide CERC order dated 12.10.2009 against petition No. 40/2009 of NHPC stands revised as 4683.82 Lakh for 2008-09. The annual fixed charge for Farakka STPS, Kahalgaon Stage-I STPS & Teesta Stage-V HPS as per CERC order dated 23.12.2009, dated 11.01.2010, dated 05.01.2010 (in Petition No-32/2007, 120/2005, 132/2009 respectively) stands revised as Rs.51836 Lakhs, Rs.31514 Lakhs & Rs. 33597.15 Lakhs respectively.
- b) Revised Allocation order of MoP/CEA vide letter No. 5/ER/CSA/GM-2010/2053, No. 5/ER/CSA/GM-2010/285-293 & No. 5/ER/CSA/GM-2010/303 dated 12.03.2010, 19.03.2010 & 29.03.2010 respectively as intimated vide ERPC letters No. ERPC/COM-I/Share/2010/ (refer Fax Msg. No. 846, 852 & 861 dated 15.03.2010, 19.03.2010 & 29.03.2010 respectively) were given effect from 00:00 hrs of 13.03.2010, 20.03.2010 & 30.03.2010 respectively.
- c) ERLDC vide their letter dated 12.09.08 intimated that 50 MW power from Mejia Unit No. # 5 of DVC being scheduled to WBSEDCL as LTOA w.e.f. 00:00 hrs of 12.09.08 which has been given effect in the REA and the necessary agreement in this regard would be effected retrospectively from the date of scheduling by concerned parties. It is requested that a copy of the agreement and LTOA order may be sent to ERPC Secretariat for record.
- d) ERLDC started scheduling 100MW power to MPPTCL as LTOA from each Unit Nos. # 5& 6 of Mejia of DVC with effect from 19:00 Hrs of 24.09.08 which has also been given effect in the REA. With effect from 01.10.2008, 150MW power allocated to NR constituents from Mejia Unit# 6 has been considered as LTOA power to NR constituents.
- e) The statement of short term bilateral transactions for the month of March' 10 will be issued separately.

Constituents are requested to intimate any discrepancy / error within two months from the date of issue of this provisional REA. In case of any discrepancy/error, the provisional REA would be revised based on re-examination, final decision and confirmation. In case no communication is received from any of the constituents indicating mistakes / discrepancy, the provisional REA as issued, would be treated as final.
