Sub: Provisional Regional Transmission Accounts (RTA) for the month of December' 2011.

Sir,

Enclosed please find the Regional Transmission Accounts (RTA) for Eastern Regional beneficiaries for the month of December, 2011 for further necessary action at your end. Please note that the withdrawal charges on account of LTA/Share for beneficiaries located in other regions would be taken care of by CTU in their respective bills.

The following have been considered for preparation of RTA for the month:

1. As per NLDC data for the month of December-11, **there is no new LTA.**
2. ERLDC vide their letter dated 12.09.08 intimated that 50 MW power from Mejia Unit No. # 5 of DVC being scheduled to WBSEDCL as LTOA w.e.f. 00:00 hrs of 12.09.08 which had been given effect in the REAs and has been considered for RTA as WBSEDCL LTA. It was informed that the necessary agreement in this regard would be effected retrospectively from the date of scheduling by concerned parties. It is requested that a copy of the agreement and LTOA order may be sent to ERPC Secretariat for record.
3. ERLDC started scheduling 100 MW power to MPPTCL as LTOA from each Unit Nos. # 5& 6 of Mejia of DVC with effect from 19:00 Hrs of 24.09.08 which had also been given effect in the REAs and has been considered as MPPTCL LTA in RTA. With effect from 01.10.2008, 150MW power allocated to NR constituents from Mejia Unit# 6 has been considered as LTOA power to NR constituents. This too has been included for calculation of LTA of respective beneficiaries.
4. Revised Allocation order(s) of MoP/CEA vide letter(s) No. 5/ER/CSA/GM-2011/956-59 dated 02.12.2011 & No. 5/ER/CSA/GM-2011/ dated 10.12.2011 as intimated vide ERPC letter(s) No. ERPC/COM-I/Share/2011/ (refer Fax Msg. Nos. M-2526 & 367 dated 02.12.2011 & 10.12.2011 respectively) were given effect from 00:00 hrs of 03.12.2011 and 11.12.2011 respectively. The same has been incorporated.

Constituents are requested to **intimate any discrepancy / error within two months** from the date of issue of this provisional RTA. In case of any discrepancy/error, the provisional RTA would be revised based on re-examination, final decision and confirmation. In case no communication is received from any of the constituents indicating mistakes / discrepancy, the provisional RTA as issued, would be treated as final.
